Thank you for your interest in the 2024 Boyle PEA VINE FEST. Please read the following rules and guidelines prior to submitting your vendor application. By submitting your application, you are agreeing to the rules below and acknowledging that you understand the guidelines.

- In order to participate in Boyle PEA VINE FEST, all items sold must be handmade/handcrafted.
- The \$75 vendor fee includes both days of the event (Friday, April 19th and Saturday, April 20th). (\$25 deposit due at time of registration). No discounts will be given for single-day participation.
- Vendor applications will not be accepted after the submission deadline of Monday, April 5th, 2024.
- <u>Submitting a vendor application does not guarantee participation.</u> All applications will be reviewed, and applicants will be contacted following the submission deadline regarding the status of their approval.
- Space is limited. Event organizers reserve the right to accept or deny any applicant based on availability, items sold, space constraints, etc. Priority will be given to vendors whose merchandise fits the overall theme of the event.
